- Core qualification for all new workers
- Specific unit on supporting adults or children and young people to access advocacy
- Included in other practice units e.g. working with children and young people who are looked after
- Specific unit in the level 5 qualification: Leadership and Management of Health and Social Care for managers of advocacy services

# Core content

- Knowledge and practice
- Understand independent advocacy
- Apply principles of independent advocacy
- Support individuals to access independent advocacy services
- Support individuals to express their views, wishes and feelings
- Support individuals to make decisions
- Continually develop own practice as an advocate
- Challenge decisions through independent advocacy
- Use advocacy to influence social change, equality and inclusion
- Understand approaches to safeguarding

- Helpu unigolion sy'n cael eu hatgyfeirio yn achos penderfyniadau sy'n ymwneud â'u gofal a chymorth
- Helpu unigolion sy'n cael eu hatgyfeirio yn achos penderfyniadau sy'n ymwneud â phryderon ynglŷn â diogelu
- Helpu unigolion sy'n cael eu hatgyfeirio yn achos materion sy'n ymwneud â chyfyngu ar neu amddifadu o ryddid

# IMCA

- Use Codes of Practice and legislation related to mental capacity to inform practice
- Provide support to individuals using non-instructed advocacy
- Understand the process of decision making
- Support individuals who are referred for decisions related to long term change of accommodation
- Support individuals who are referred for decisions related to serious medical treatment
- Support individuals who are referred for decisions related to their care and support
- Support individuals who are referred for decisions related to safeguarding concerns
- Support individuals who are referred for issues related to restrictions or deprivations of liberty

- Helpu unigolion a/neu ofalwyr sy'n cael eu hatgyfeirio at wasanaeth eirioli annibynnol
- Helpu unigolion a/neu ofalwyr i gyflwyno eu safbwytiau, eu dymuniadau a'u hoffterau mewn cyfarfodydd gwneud penderfyniadau
- Cyflwyno safbwytiau, dymuniadau a hoffterau unigolion /neu ofalwyr mewn cyfarfodydd lle na allant wneud hynny eu hunain
- Helpu unigolion a/neu ofalwyr i ddefnyddio prosesau anffurfiol a/neu ffurfiol i herio penderfyniadau

# Independent advocacy with adults

- Use legislation related to independent advocacy to inform practice
- Support individuals and/or carers who are referred for independent advocacy
- Support individuals and/or carers to present their views, wishes and preferences at decision making meetings
- Present individuals and/or carers views, wishes and preferences at meetings where they are not able to do so themselves
- Support individuals and/or carers to use informal and/or formal processes to challenge decisions

- Darparu gwybodaeth am gymorth eiriolaeth i blant a phobl ifanc
- Darparu cymorth a chynrychiolaeth eiriolaeth i blant a phobl ifanc sy'n cael eu hatgyfeirio at eiriolaeth annibynnol
- Helpu plant a phobl ifanc i gyflwyno eu safbwytiau, eu dymuniadau a'u hoffterau mewn cyfarfodydd gwneud penderfyniadau
- Cyflwyno safbwytiau, dymuniadau a hoffterau plant a phobl ifanc mewn cyfarfodydd lle na allant neu nad ydynt yn dymuno gwneud hynny eu hunain
- Helpu plant a phobl ifanc i ddefnyddio prosesau anffurfiol a/neu ffurfiol i herio penderfyniadau

# Independent advocacy with children and young people

- Use legislation related to independent advocacy to inform practice
- Provide information about advocacy support for children and young people
- Provide advocacy support and representation to children and young people who are referred for independent advocacy
- Support children and young people to present their views, wishes and preferences at decision making meetings
- Present children and young people's views, wishes and preferences at decision making meetings where they are not able to or do not wish to do so themselves
- Support children and young people to use informal and/or formal processes to challenge decisions



# Fframwaith Cymwysterau Gofal Cymdeithasol Cymru

- Rhestro cymwysterau sy'n ofynnol ac sy'n cael eu hargymhell
- Derbynir y diploma Lefel 3 fel cymhwyster rhagflaenu (arall) ar ôl cyflwyno'r cymhwyster newydd
- Bydd y diploma lefel 3 yn parhau i gael ei derbyn i ymarfer

# Social Care Wales Qualification Framework

- Lists recommended and required qualifications
- Level 3 diploma will be accepted as a predecessor (other) qualification after the new qualification goes live
- The level 3 diploma will continue to be accepted for practice

- Dim unedau atodol ar gael
- Y cyflogwr sy'n gyfrifol am sicrhau bod eiriolwyr yn gymwys i ddarparu'r gwasanaeth

# What is different

- One level 4 qualification
- Change in structure to reduce duplication and repetition
- Equal status to all forms of advocacy
- No top up units available
- Employer responsibility to ensure that advocates are competent to deliver the service
